RESPONSIBILITY OF USE

You shall assume all responsibility for all content distributed, accessed, or viewed while connected to our Services. Under no circumstances shall we be held liable for your actions while you are using the Services. In the event of a court order, we may provide any and all information requested, as described in the Customer Privacy Notice, which is accessible on the Choptank Fiber website.

PROHIBITED CONDUCT

You will violate this Agreement if you engage in the following examples of prohibited activities while using our Services:

- 1. Spamming:
 - > Sending unsolicited bulk and/or commercial messages over the Internet.
 - Maintaining an open SMTP relay.
- 2. Facilitating a Violation of this Policy:
 - Advertising, transmitting, or otherwise making available any software, program, product, or service that is designed to violate this Policy, which includes the facilitation of the means to spam, initiation of pinging, flooding, mailbombing, denial of service attacks, and piracy of software.

3. Infringing Intellectual Property Rights:

- Engaging in any activity that:
 - Infringes or misappropriates the intellectual property rights of others, including copyrights, trademarks, service marks, trade secrets, software piracy, and patents held by individuals, corporations, or other entities.
 - Violates privacy, publicity, or other personal rights of others.

4. Obscene Speech or Materials:

➤ Using Choptank Fiber, LLC's Services to advertise, transmit, store, post, display, or otherwise make available child pornography or other forms of illegal pornography or obscene speech or material. Choptank Fiber, LLC shall notify law enforcement agencies when it becomes aware of the presence of child pornography on or being transmitted through Choptank Fiber, LLC's Services.

5. Promoting Violence or Injury:

- Advocating, promoting, or providing assistance in carrying out violence or any other unlawful activity against any persons, animals, or any governments, businesses, or other entities.

9. Distribution of Internet Viruses, Worms, Trojan Horses, or Other Destructive Activities:

10. Export Control Violations:

Exporting encryption software over the Internet or otherwise, to points outside Canada or the United States.

11. Illegal Activities:

Engaging in activities that are determined to be illegal, including advertising, transmitting, or otherwise making available Ponzi schemes, pyramid schemes, fraudulently charging credit cards, and pirating software.

12. Gambling:

Engaging in or promoting gambling contrary to any laws.

13. Promoting Intoxicants:

➤ Displaying or promoting any type(s) of intoxicant, alcoholic beverage, cigarettes or illegal substance contrary to any laws.

14. Instructing Others in Prohibited Activities:

Providing instructions with respect to any activities listed above.

15. Other Activities:

Engaging in any other activity, whether lawful or unlawful, that Choptank Fiber, LLC in its sole discretion determines to be harmful to customers, operations, reputation, goodwill, or customer relations.
